Minutes, May 3, 2011 Regular Meeting

Vincent DeCario, Chairman, called the regular meeting of the Derry Township Board of Supervisors to order in the Municipal Building at 5321 Route 982, Derry, PA at 7:00 p.m. and lead the group with the Pledge of Allegiance.

Members present were: Vincent DeCario, David Slifka, and Daniel Rullo-Supervisors; Terry Giannini, Code Enforcement Officer and Lynne Finnerty, Solicitor

The meeting was opened to the public for comments: Chairman Vince DeCario announced that residents recycled 13.56 tons of newspapers during March and won Paper Retriever's 2011 Earth Day Challenge, an award for commitment to paper recycling and dedication to environmental stewardship. In addition Derry Township received a check from Paper Retriever in the amount of \$542 which is double the normal amount received.

April Rob, Derry Ag Fair Board Secretary, asked if the Board intended to adopt a policy for "Young Lungs at Play" presented at last month's meeting and if she could get a contact person to present a program at the Derry Ag Fair this year. Chairman DeCario explained a resolution is being prepared for next month's meeting and contact information will be given so a program can be presented at the fair. April also questioned if any donation will be made to the Derry Township Ag Fair this year. She was advised a request must be sent in writing to the Board. A decision will be made at next month's meeting regarding donations.
