

## **DERRY TOWNSHIP BOARD OF SUPERVISORS**

### Minutes, August 2, 2016 Regular Meeting

**7:00 p.m.**

The regular meeting of the Derry Township Board of Supervisors was called to order in the Municipal Building at 5321 State Route 982, Derry, PA at 7:00 p.m. and the Pledge of Allegiance was recited.

The meeting was opened to the public for comments. Dennis Brantner voiced his concern regarding a pipe that is backing up at his residence in Snydertown. Dave Slifka explained that there is both a low pressure gas line and a medium pressure gas line above this drain in the area. A fifteen-inch or eighteen -inch pipe is needed but it is not a good idea to put this above or underneath these gas lines and the main water line goes through this area. A plan is in the works to move the gas lines but has not been completed. A discussion was held.

Randy Ankney addressed the Board regarding an app for smart phones that direct 9-1-1 calls to the correct County. A discussion was held.

Sam Calabrace of 2902 Ligonier Street stated he was not in favor of the Latrobe Foundation installing a walk path adjoining his property. The Solicitor Nate Boring stated there was nothing the Township could do because the Latrobe Foundation owns the property but Mr. Calabrace would have to hire an attorney to take action against the Latrobe Foundation. A discussion was held.

Joann Cinibulk questioned the newspaper article regarding the recycling bin at the Township building and wants the Board to adopt mandatory garbage for all residents. A discussion was held.


