Minutes, December 2, 2014 Regular Meeting

Mrs. Hammers stated if a homeowner submits the application, the cost is \$250 to DEP and \$225 to the Westmoreland Conservation District but if the municipality submits the application, there is no fee. There is a 60-day review period prior to approval of the permit. Mrs. Hammers requested the Township submit the application to help the homeowners. Vincent DeCario stated the Board will discuss this issue tomorrow and let her know the decision.

Jessica Yacobucci questioned if any action has been taken regarding securing water for the resident\s along State Route 981 as discussed at last month's meeting. Vincent DeCario stated he spoke with WXP Energy but they have not gotten back to him. A discussion was held.
